Before sending or dropping off your document first Verify with us at ALSC by email or using our customer service helpline that it is ready for processing, this will save any delays.

Once verified decide on Service Speeds and whether you are going to provide the money order for payment of the Embassy Fee or if you want us to obtain this for you. Make sure you have included any embassy requirements as advised by us at ALSC.

Decide how you want your Document returned Canada Post regular mail is free of charge and so is pick up at any of our service centers. Or include an self addressed prepaid return courier waybill, prepaid Canada Post Xpresspost envelope, or confirm that you have chosen our return shipping services.

Choose your Payment Method We accept payment by Visa, MasterCard (credit cards only), e-Transfer, PayPal, corporate cheque or money order payable to "Auth. Legz. Services Canada". Remember to enclose payment before shipping or that you have included the Credit Card Authorization Form.

Complete and Print Order Form To help us with the processing of your document please complete each section of the Order Form clearly. If you do not include an Order Form it will cause delays.
